The focus is on seeking compatible and effective approaches to addressing current sustainable development challenges.

- Role of Public Authorities in Ensuring Sustainable Development of a Region.
- Social Entrepreneurship and Public Administration in the Context of Modernizing Regional Economies.
- Legal Issues of Ensuring Conditions for Sustainable Development.
- Sustainable Territorial Development on the Path to European and Euro-Atlantic Integration.
- Education and Science for Sustainable Development.
- Financial Mechanisms for Ensuring Balanced Growth.
- Security and Competitiveness as Conditions for Sustainable Territorial Development.
- Pragmatic Aspects of Sustainable Development of Public Administration in Business and the Public Sector.

The conference's scope is not limited to the outlined issues and can be expanded based on the authors' scientific interests within the conference's theme.

Final deadlines for participation in the conference:

- Registration and submission of abstracts deadline: until October 1, 2023.
- Notification of acceptance or rejection of abstracts: until October 15, 2023.
- Registration fee payment deadline: until October 15, 2023.

ORGANIZATIONAL CONDITIONS AND FORMATTING REQUIREMENTS

Formatting Requirements: Submitted materials should reflect the latest research, align with the conference theme, and present original findings that have not been previously published. The organizing committee reserves the right to reject materials that do not meet requirements or falloutside the conference's scope.

Materials for publication should be presented on A4-sized pages with a 1.15 line spacing, Times New Roman font of size 12, in both Ukrainian and English languages. All margins should be 2 cm.The UDC number is placed in the upper left corner. Author information (last name, first name, patronymic, academic degree, title, full institution name, and position) is provided in the upper right corner. The title of the article is centered below the author's information, followed by the main text and references with in-text citations according to DSTU 8302:2015 Information and Documentation. Bibliographic Reference. General Principles and Rules / National Standard.

Text file formats should be Microsoft Word DOCX / DOC. Graphical images contained within the text (drawings, sketches, photographs, graphics, schemes, diagrams) should be provided separately in PDF or PNG format.

Equations should be centered and labeled. The organizing committee recommends preparing equations using MS Equation or MathType software. When referencing equations, figures, tables, or literature in the text of the materials, use expressions such as Eq. (1), equations (1) and (2); Fig. 1; Table 1; [1, p. 2] (for literature references).
